

**A&E® Fall Into Adventure Sweepstakes  
Official Rules**

1. NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID ANYWHERE OUTSIDE OF THE 50 UNITED STATES AND THE DISTRICT OF COLUMBIA, AND WHEREVER PROHIBITED OR RESTRICTED BY LAW.

2. **Eligibility/Participation:** A&E® Fall Into Adventure Sweepstakes (the “Sweepstakes”) is open to legal residents of the fifty (50) United States (including the District of Columbia), who are at least eighteen (18) years of age, or the age of majority in their jurisdiction of residence, whichever is greater, at the time of Entry (defined below). Employees, their immediate families (*i.e.*, parents, spouse, children, siblings, grandparents, step parents, step children and step siblings) of A&E Television Networks, LLC (“Sponsor”), Advantage Sales & Marketing LLC, d/b/a The Sunflower Group (“Administrator”), Universal City Development Partners, Ltd. d/b/ Universal Orlando Resort (“Universal Orlando”), Universal City Studios LLC d/b/a Universal Studios Hollywood (“Universal Hollywood”), and their respective affiliated companies, sponsors, subsidiaries, advertising agencies and third party fulfillment agencies (collectively, with Sponsor, the “Sweepstakes Entities”) are not eligible to enter the Sweepstakes. Universal Orlando and Universal Hollywood may also be collectively referred to herein as “Prize Provider” or “Prize Providers.” By participating in this Sweepstakes, entrants agree to: (a) be bound by these Official Rules and by the interpretations of these Official Rules by Sponsor, and by the decisions of Sponsor, which are final in all matters relating to the Sweepstakes; and (b) release and hold harmless each of the Sweepstakes Entities and their respective agents, employees, officers, directors, successors and assigns, against any and all claims, injury or damage arising out of or relating to participation in this Sweepstakes and/or the use or misuse or redemption of a prize, and for any claims based on publicity rights, defamation, invasion of privacy, copyright infringement, trademark infringement or any other intellectual property related cause of action.

3. **Sweepstakes Period:** The Sweepstakes commences at 12:00 PM Eastern Time (“ET”) on September 17, 2019, and ends at 11:59 AM ET on October 28, 2019 (the “Sweepstakes Period”).

4. **How To Enter:** During the Sweepstakes Period, you may submit one (1) Entry into the Sweepstakes by visiting <https://www.aetv.com/Universalsweeps> (“Site”) and following the on-screen instructions in order to complete and submit the online form, including your name and valid email address (“Entry”). Entries must be received by 11:59 AM ET on October 28, 2019 to be eligible for the Sweepstakes. Limit one (1) Entry per person/email address, per day. Use of computer programs and other automatic means to enter the Sweepstakes is prohibited. Any attempt by any entrant to obtain more than the stated number of Entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void such Entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Normal Internet/phone access and data/usage charges imposed by your online/phone service may apply. The Sponsor’s database clock will be the official timekeeping device of the Sweepstakes. In the event of any dispute concerning the identity of any entrant, the relevant Entry will be deemed submitted by the authorized email address account holder of the email address used to enter. Entries generated by script, macro or other automated means and entries by any means which subvert the Entry process are void. Entrants understand that they are providing their information to Sponsor. To participate in this Sweepstakes, each entrant will be subject to the Sponsor’s Terms of Use (<https://www.aenetworks.com/terms>) and Privacy Policy (<http://www.aenetworks.com/privacy>). Please read these policies before entering the Sweepstakes.

5. **Grand Prize Random Drawing:** On or about November 1, 2019, Administrator will perform one (1) Grand Prize random drawing (the “Grand Prize Drawing”), from among all eligible Entries received throughout the entire Sweepstakes Period, in order to select one (1) potential Grand Prize winner. The odds of being selected as the potential Grand Prize winner will depend upon the total number of eligible Entries received throughout the Sweepstakes Period.

6. **Grand Prize/Approximate Retail Value (“ARV”):** There is one (1) Grand Prize available to be awarded in this Sweepstakes. Once confirmed as the official Grand Prize winner (“Winner”), as detailed below, the Winner will receive a 4-day/3-night trip for Winner and up to three (3) guests (“Guests,” each a “Guest”) to Winner’s choice of either (a) Universal Orlando Resort in Orlando, FL (“UO Trip”), or (b) Universal Studios Hollywood in Hollywood, CA (“USH Trip”). UO Trip and USH Trip may be collectively referred to as “Trip” or “Trips”, unless otherwise specifically identified herein.

- a. If the UO Trip is chosen, the Grand Prize will include: (a) round trip economy class air transportation for Winner and up to three (3) Guests from a major commercial airport near Winner's home (as determined by Universal Orlando in its sole discretion) to Orlando, FL\*; (b) three (3) nights' standard hotel accommodation (one room, quadruple occupancy, room and tax only) at Universal's Endless Summer Resort – Surfside Inn and Suites (or another Universal Orlando Resort hotel as determined by Universal Orlando in its sole discretion); (c) non-exclusive ground transportation to and from airport and hotel in Orlando, FL\*; (d) 3-Park 3-Day Park-to-Park tickets for admission to Universal Studios Florida and Universal's Islands of Adventure theme parks, and Universal's Volcano Bay water theme park for Winner and up to three (3) Guests; (e) and admission to one (1) Blue Man Group Show (exact date and time to be determined by Universal Orlando in its sole discretion) for Winner and up to three (3) Guests.

\*For a winner who is a Florida resident, and selects the UO Trip, air transportation may be substituted with another method of transportation by Universal Orlando in its sole discretion.

- b. If the USH Trip is chosen, the Grand Prize will include: (a) round trip economy class air transportation for Winner and up to three (3) Guests from a major commercial airport near Winner's home (as determined by Universal Studios Hollywood in its sole discretion) to Los Angeles, CA\*\*; (b) three (3) nights' standard hotel accommodation (one room, quadruple occupancy, room and tax only) at Sheraton Universal Hotel (or another nearby hotel as determined by Universal Studios Hollywood in its sole discretion); (c) non-exclusive ground transportation to and from airport and hotel in Los Angeles, CA\*\*; and (d) two (2) days General Admission tickets to Universal Studios Hollywood for Winner and up to three (3) Guests.

\*\*For a Winner who is a California resident and selects the USH Trip, air transportation may be substituted with another method of transportation by Universal Hollywood in its sole discretion.

The ARV of the Grand Prize if the UO Trip is selected is Three Thousand Eight Hundred Twenty-Four and 64/100 Dollars (\$3,824.64). The ARV of the Grand Prize if the USH Trip is selected is Four Thousand Eight Hundred Sixty-Nine and 00/100 Dollars (\$4,869.00).

7. **Prize Winner Notification/Verification:** On or about one (1) business day after the Grand Prize Drawing, Administrator will notify the potential Winner via the email address provided on their online Entry form. The potential Winner will be required, as a condition of verification and acceptance, to sign and return, within 48 hours of Sponsor's request, an Affidavit of Eligibility and Release of Liability and Publicity Release (where permitted by law) ("Release"). Failure to return the Release within such time period shall result in disqualification without further notification and an alternate potential Winner will be selected from among the remaining applicable Entries. By entering, all Entrants and the potential/confirmed Winner hereby consent to the use by the Sweepstakes Entities of their Entry and all information contained therein including but not limited to: name, likeness, opinions, images, statements and/or other indicia of persona, and personally identifiable information (collectively "Likeness"), for any and all uses and purposes in any media now known or hereinafter developed throughout the world (including the World Wide Web and on-air) without additional consideration (where legal), consent or prior review, and upon request will provide written consent to such use. Noncompliance, failure to return any documents within the time specified, failure to respond to notification attempts or returns of prize/prize notification as undeliverable will result in disqualification and an alternate potential winner will be selected. If Sponsor is unable to verify a Winner after selecting two (2) alternate potential winners, the Grand Prize may not be awarded, in Sponsor's sole discretion. Winner must also complete any additional legal documents provided by Sponsor (or third party on its behalf, if applicable) with respect to his or her prize and return them as instructed within the timeframe specified by Sponsor or prize winner may forfeit the prize at Sponsor's sole discretion. All decisions of Sponsor relating to the Sweepstakes are final.

8. **General Prize Conditions:** All prize details are at Sponsor and/or Prize Provider's discretion. In no event will Sponsor and/or Prize Provider be responsible for awarding more than the prize detailed herein. No transfer or substitution will be permitted, except at Sponsor and/or Prize Provider's sole discretion, due to prize unavailability for any reason. Regardless of selected destination, Trip must be taken by **October 28, 2020**. It is the responsibility of the Winner and his/her Guests to be in possession of all necessary travel documentation (e.g., valid photo ID, valid credit card) at the time and place of departure, or prize may be forfeited. Winner's Guests must be at least eighteen (18) years old unless the Winner is the

Guest's parent or legal guardian and must travel on the same itinerary and at the same time as the Winner. If Winner is between the ages of eighteen (18) and twenty-one (21), he/she must be accompanied by an adult of at least twenty-one (21) years of age in order to check into the hotel. Actual value of the Grand Prize depends on any fluctuations in current market conditions at time of prize fulfillment, and the location of winner's residence and selected prize choice. Any difference between the stated ARV and the actual value, if any, will not be awarded. Trip is subject to air/hotel availability, work stoppages, schedule or route changes, holiday and blackout dates, and any other travel conditions/restrictions that may apply. Travel arrangements will be made through Prize Provider's agent on a carrier of Prize Provider's choice unless otherwise decided by Prize Provider in its sole discretion. No refunds or credit for changes are allowed. Winner will be required to provide a valid major credit card or some other acceptable form of payment, as determined in the hotel's sole discretion upon hotel check-in and all in-room charges, telephone calls, meals, beverages, hotel upgrades, amenities, personal incidentals and any other expenses charged to the winner's hotel room will be charged to that major valid credit card. In the event the Winner or his/her Guests engage in behavior that (as determined by Sponsor and/or Prize Provider in Sponsor and/or Prize Provider's sole discretion) is inappropriate or threatening, illegal or that is intended to annoy, abuse, threaten or harass any other person, Sponsor and/or Prize Provider reserve the right to terminate the trip early and send the Winner and/or his/her Guests home with no additional compensation. All other expenses relating to acceptance of the Grand Prize not explicitly stated herein, are solely the responsibility of the Winner. Complete terms and conditions of Grand Prize trip will be furnished with prize notification and/or further correspondence. Prize Provider reserves the right to structure the travel route in their sole discretion. Grand Prize trip may not be combined with any other offer and travel may not qualify for frequent flyer miles. Sweepstakes Entities will not replace any lost or stolen tickets, travel vouchers, or certificates once in Winner's possession. Once travel commences, no unscheduled stopovers are permitted; if an unscheduled stopover occurs, full fare will be charged from stopover point for the remaining segments, including return. Once issued, tickets are nontransferable and may not be reissued once travel has commenced. Open tickets may not be issued and stopovers are not permitted. Sweepstakes Entities are not responsible for any expenses that may be incurred as a consequence of a transportation cancellation/delay. Theme Park and show tickets are subject to separate terms and conditions set by the issuer and an expiration date may apply. Administrator will furnish an Internal Revenue Service Form 1099 to the Winner for the actual retail value of the Grand Prize for the tax year in which Grand Prize is accepted. All taxes on the Grand Prize are Winner's sole responsibility. The Sweepstakes Entities shall not be responsible for any cancellations, delays, diversions or substitutions or any act or omissions whatsoever by the air carriers, hotels or other transportation companies or any other persons providing any of these services and accommodations including any results thereof such as changes in services or accommodations necessitated by same. If Winner elects to partake in any or all portions of the Prize with fewer than three (3) Guests or no Guest, such portion(s) of the Prize will be forfeited and Sweepstakes Entities shall owe no substitution or compensation in lieu therewith.

9. **General Terms:** Noncompliance with any of these Official Rules may result in disqualification. Sponsor assumes no responsibility for incorrect or inaccurate Entry information whether caused by any of the equipment or programming associated with or utilized in this Sweepstakes or by any human error, which may occur in the processing of the Entries in this Sweepstakes. Sponsor is not responsible for any problems or technical malfunctions of any telephone network or lines, computer online systems, servers or other services, or providers, computer equipment, software, failure of any e-mail or players on account of technical problems or traffic congestion on the Internet or the Site or at any website, or any combination thereof, including, without limitation, any injury or damage to entrant's or any other person's computer related to or resulting from participation or downloading any materials in this Sweepstakes. Sponsor is not responsible for any typographical or other error in administration of the Sweepstakes, or in the announcement of the Winner. If, for any reason, the Sweepstakes is not capable of running as planned, including, without limitation, infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of the Sponsor which corrupt or affect the administration, security, fairness, integrity or proper conduct of this Sweepstakes, the Sponsor reserves the right in its sole discretion to cancel, terminate, modify or suspend the Sweepstakes. Should the Sweepstakes be terminated prior to the stated expiration date, notice will be posted on the Site or elsewhere as Sponsor sees fit, and the Grand Prize will be awarded via random drawing from among all eligible Entries received up until the time of cancellation or termination or in a manner that is fair and equitable as determined by Sponsor. All interpretations of these Official Rules and decisions by Sponsor are final. No software-generated, robotic, programmed, script, macro or other automated Entries are permitted. Sponsor reserves the right in its sole discretion to disqualify any individual it suspects or finds: (i) to have used a software-generated, robotic, programmed, script, macro or other automated online Entry; (ii) to have tampered with the Entry process or the operation of this Sweepstakes; (iii) to be acting in violation of these Official Rules; (iv) to be acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person; or (v) to have provided inaccurate information on any legal documents submitted in connection with this Sweepstakes. THE NEW YORK COURTS (STATE AND FEDERAL) SHALL HAVE SOLE JURISDICTION OF ANY CONTROVERSIES REGARDING THE SWEEPSTAKES AND THE LAWS OF THE STATE OF NEW YORK SHALL GOVERN THE SWEEPSTAKES; PROVIDED, HOWEVER, THAT CLAIMS FOR BODILY INJURY, PERSONAL INJURY, OR PROPERTY DAMAGE ARISING OUT OF THE REDEMPTION, USE OR MISUSE OF THE UO TRIP (“UO TRIP PRIZE CLAIMS”) MUST BE SUBMITTED TO THE JURISDICTION AND VENUE OF THE FEDERAL AND STATE COURTS OF THE STATE OF FLORIDA, AND CONSTRUED AND ENFORCED IN ACCORDANCE WITH THE LAWS OF THE STATE OF FLORIDA AND CLAIMS FOR BODILY INJURY, PERSONAL INJURY, OR PROPERTY DAMAGE ARISING OUT OF THE REDEMPTION, USE OR MISUSE OF THE USH TRIP (“USH TRIP PRIZE CLAIMS”) MUST BE SUBMITTED TO THE JURISDICTION AND VENUE OF THE FEDERAL AND STATE COURTS OF THE STATE OF CALIFORNIA, AND CONSTRUED AND ENFORCED IN ACCORDANCE WITH THE LAWS OF THE STATE OF CALIFORNIA. EACH ENTRANT WAIVES ANY AND ALL OBJECTIONS TO JURISDICTION AND VENUE IN THESE COURTS AND HEREBY SUBMITS TO THE JURISDICTION OF THOSE COURTS. ENTRANT AGREES THAT ANY AND ALL DISPUTES, CLAIMS AND CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH THIS SWEEPSTAKES OR ANY PRIZE AWARDED SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION AND IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK (EXCLUDING UO TRIP PRIZE CLAIMS AND USH TRIP PRIZE CLAIMS) WITHOUT REGARD TO PRINCIPLES OF CONFLICTS OF LAW.

10. **Limitation of Liability:** Entrants agree that the Sweepstakes Entities (a) shall not be responsible or liable for, and hereby release the Sweepstakes Entities from, any claims, losses, damages or injuries of any kind (including death) resulting, in whole or in part, directly or indirectly, from participation in the Sweepstakes or any Sweepstakes-related activity, or from acceptance, receipt, possession and/or use/misuse or inability to use the prize, and (b) have not made any warranty, representation or guarantee, express or implied, in fact or in law, with respect to the prize, including, without limitation, to such prize’s quality or fitness for a particular purpose. Sponsor and the Sweepstakes Entities shall not be liable for any injury, damage, loss, expense, accident, delay, inconvenience or irregularity that may be caused or contributed to (1) by any wrongful, negligent or unauthorized act or omission on the part of any of their agents, servants, employees or independent contractors; (2) by any wrongful, negligent or unauthorized act or omission on the part of any other person or entity not an employee of the Sweepstakes Entities; or (3) by any other cause, condition or event whatsoever beyond the control of the Sweepstakes Entities.
